*CDSF Motion RE: PD athletes' Adj. Licences*

According the decision of WDSF AGM 2019 (see Minutes, line 790-792) **MOVED**, the **WDSF Competition Rules point C.5.6** be changed as shown below in order to let active professional dancers with the valid WDSF adjudicators licence judge in the position of B licenced adjudicators in the events without PD competitions.

**C.5.6** An athlete may not ~~adjudicate or~~ chair WDSF DanceSport competitions until after declaring in writing that he or she has ceased to compete.

and new point be added:

**C.5.7 A PD athlete holding a WDSF Adjudicators license cannot adjudicate in any event with PD competitions.**

and conditions of Adjudicators licence B under point X.3 be changed as shown below:

old text X3:

Licence B:

- .a) Over 21 years old.
- .b) Must be a former (retired) DanceSport Competitor of Grade A or S Class and competed in International Competitions.
- .c) Holder of a National Adjudicator License for a minimum of 2 years with qualification to judge National Championships.
- .d) Must have passed National Adjudicator's course and Technical Examination (Pre-qualified by WDSF Presidium) or passed WDSF Technical Examinations conducted by WDSF Technical Examiners.
- .e) Must have attended two (2) WDSF Adjudicator's congresses and passed the WDSF General Knowledge Test and the WDSF English comprehension examination.

**new text X.3:**

**Licence B:**

- .a) Over 21 years old.
- .b) Must be
  - a **former** Dancesport competitor **having competed in**
    - o **the Adult category of Grade A or S Class, or**
    - o **Professional division (5 dances) in the highest national class, or**
  - a **current** DanceSport Competitor **competing in Professional division and having achieved final at the World Championships in STD, LAT or 10 Dance.**

.c) Must have competed in Adult or Professional categories for at least 2 years and participated in at least 10 International events.

.d) Must be a holder of the highest National Adjudicator's License for a minimum of 2 years.

.e) Must have passed National Adjudicator's course and Technical Examination (Pre-qualified by WDSF Presidium) or passed WDSF Technical Examinations conducted by WDSF Technical Examiners.

.g) Must have attended two (2) WDSF Adjudicator's congresses and passed the WDSF General Knowledge Test and the WDSF English comprehension examination.

**Explanation:**

PD athletes are mostly very good experts not only in competing and teaching/training, but in judging with experience from top national competitions. Some member bodies allow it with good experience.

Such experts can increase the panels credibility, which is very needed today.

The previous motions, discussed at WDSF PD AGM and WDSF AGM in 2018 and 2019, has been extended to include:

- Holders of WDSF Adjudicators licence A (last discussed version solved only B licenced adjudicators)
- Special conditions for former PD athletes, who have only reached the desired level in PD
- Special conditions for active top PD athletes (finalists)
